The Applied Holistic Nutrition program provides a Diploma upon graduation and a Certified Nutritional Practitioner (CNP) certification. There are 713.5 in-class hours, with the full-time program lasting 11 months and the part-time program lasting 22 months. Language of Instruction: English

\*You may submit the above documentation through mail, email, or to your desired campus. Please note that space cannot be reserved without a completed enrolment contract, an interview with a program advisor, other required documentation, and a non-refundable tuition deposit/enrolment fee of \$500 + HST, regardless of the chosen payment option.

#### Payment Options (Current fees are applicable to students commencing the program in the year of 2017)

Upon registration, IHN requires a \$500 non-refundable tuition deposit/enrolment fee. Acceptable methods of payment are Cash, Cheque, Interac, MasterCard, Visa and Money Order. All tuition invoices/receipts are e-mailed, unless requested otherwise. You have one opportunity to change your payment plan in relation to options B through D.

Option A Payment in full on day of registration of \$6,890 + HST (non-refundable tuition deposit/enrolment fee of \$500 + HST included) for the complete Full or Part-time diploma programs. This option is not available after the commencement of classes.

## Full-Time Program (One Year)

Monday - Thursday, 10:00am - 2:00pm. First installment is due one week before the first day of class.

Option B Deposit due with registration: \$500 + HST 2 installments (5-month intervals): \$3,295.00 + HST

Option C Deposit due with registration: \$500 + HST

3 installments (4-month intervals): \$2,230.00 + HST

### Part-Time Program (Two Year)

Daytime program is either Monday/Wednesday or Tuesday/Thursday from 10:00am - 2:00pm. (Approximately Two Year) Evening program - Monday and Thursday evenings from 6:00pm - 9:30pm. First installment is due one week before the first day of class.

Option B Deposit due with registration: \$500 + HST

Option C Deposit due with registration: \$500 + HST

3 installments (6-month intervals): \$2,213.33 + HST

4 installments (5-month intervals): \$1,685.00 + HST

Option D, per course payments, please view page 5 or ask a Program Advisor at your desired campus. A change of payment plan D is permitted within the first 6 months. Payment plan D can only be changed to payment plan B or C. First payment is due one week before the first day of class.

#### **Course Exemptions**

Official transcripts must be submitted before the commencement of the program in order for a tuition reduction to be processed for exemptions granted. Official transcripts submitted after the commencement of the program will receive consideration for course exemption but will receive NO tuition credit.

#### Withdrawal and Refund Policy

#### **Full Refunds**

The Institute of Holistic Nutrition shall refund all of the fees paid by a student within 30 days under a contract for the provision of a vocational program in the following circumstances:

- 1. The contract is rescinded by a student within two days of signing a contract
- 2. The Institute of Holistic Nutrition discontinues the vocational program before the student completes the program, unless the discontinuance of the program coincides with The Institute of Holistic Nutrition ceasing to operate
- 3. The Institute of Holistic Nutrition expels the student from the college in a manner or for reasons that are contrary to the school's expulsion policy

A refund is not payable unless a student delivers a written demand to The Institute of Holistic Nutrition at the address shown on the contract.

Full refund of books purchased from The Institute of Holistic Nutrition applies if returned to the original campus of purchase within 10 days of the students' withdrawal or expulsion from the program, and unopened or in the same state when supplied.

#### **Partial Refunds**

A portion of the tuition fees may be refunded if the school receives written notice of withdrawal postmarked before the applicable deadline. Failure to attend class does not constitute an automatic withdrawal. Processing of refunds requires 30 days.

#### **Partial Refunds Before Commencement of a Program**

- A student withdrawing from the program before it begins would be entitled to receive a full refund of fees paid for the program
  minus the non-refundable tuition deposit/enrolment fee of \$500 + HST
- If a student does not attend a program during the first 14 days, The Institute of Holistic Nutrition can give the student a written notice that is cancelling the contract. In such case, the student is entitled to receive a full refund of fees paid for the program minus the non-refundable tuition deposit/enrolment fee of \$500 + HST

#### **Partial Refunds After Commencement of a Program**

- A student would be entitled to a partial refund if they withdraw or have been expelled before half of the total number of hours are delivered
- The amount of the refund that The Institute of Holistic Nutrition shall give a student shall be equal to the full amount of the fees paid in respect of the program less,
  - a) the \$500 + HST non-refundable tuition deposit/enrolment fee; and
  - b) a portion of the fees in respect of the program/course that is proportional to the number of hours of instruction that have elapsed at the time of the withdrawal or expulsion

For Payment Plan Option D only, a student withdrawing from a specific course within the program before 30% of the total number of hours are delivered will be granted full refund of a course fee when the school receives a written notice of withdrawal from the course postmarked before the applicable deadline.

#### **Additional Considerations:**

- The non-refundable registration deposit of \$500 + HST is valid up to one year, after which time the registration is null and void
- Upon program commencement, the deposit and tuition paid to date is valid up to five years from the program withdrawal date and may be used towards the regular diploma program only
- If an individual withdraws, or does not pursue enrolment into courses, for over a period of five years, all Nutrition-related courses must be retaken due to the current nature of the course material
- An individual has up to ten years to complete the program from the initial start date
